MEMORANDUM OF UNDERSTANDING (SkillPlus)

THIS MEMORANDUM OF UNDERSTANDING ('MOU') is made at Hubballi, Karnataka, India on this <date> day of <month> 2021 by and between:

Deshpande Educational Trust, a charitable trust incorporated under the Indian Trusts Act 1882, and having its principal office at Airport Road, Hubballi, Karnataka 580030 India, (hereinafter "Deshpande Skilling") duly represented by its <designation Chief Operating Officer, Mr. P.N. Nayak, which expression shall unless it is repugnant to the meaning or context thereof be deemed to mean and include its successors and assigns

AND

"Karnataka Lingayat Education Society (KLE's)" which houses numerous centers of collegiate education that offer a wide range of curricula across faculties of Arts, Science and Commerce for graduation and post-graduation thereby facilitating skill development and enhanced employability and having its presence in Districts of Belagavi, Dharwad, Gadag, Haveri represented by its Chairman of the Karnataka Lingayat Euducation Society "Dr Prabhakar Kore" (hereinafter referred to as "KLE Society", which expression shall, unless repugnant to the meaning or context thereof, be deemed to mean and include its successors and permitted assigns. The degree colleges of the KLE Society offering collegiate education hereinafter referred to as KLE Colleges)

AND

DESHPANDE SKILLING and **The KLE Society** are hereinafter collectively referred to as 'Parties' and individually as a 'Party'.

WHEREAS:

1. DESHPANDE SKILLING a "not for profit" trust, an impact unit of Deshpande Foundation, India, and a training partner of National Skill Development Corporation (NSDC), involved in the activity of conducting employability skills training programs for graduates from rural and semi-urban colleges at various colleges and its skilling campus in Hubballi, and providing placement assistance to its students. Deshpande Skilling is desirous of bringing about rural transformation by building employability skills among graduate youth from rural and semi-urban colleges and assists them to earn their first employment in the formal sector. Deshpande Skilling wishes to skill job-seeking students pursuing graduation/graduates that pass out of college but





have failed to acquire the required skills to earn employment through its Non-Residential (SkillPlus) and Residential (SkillPlus-R) skilling programs.

- 2. The KLE Society is desirous to see more of its KLE College students succeed in earning their employment in reputed organizations and enhancing the placement record of the KLE colleges. Therefore, the name, location and other details of the KLE Colleges, which will be part of the "SkillPlus" nonresidential skilling partnership, is listed in Annexure-A of this MOU.
- The two parties, DESHPANDE SKILLING and The KLE Society, seek to partner with each other to achieve the common goal of skilling select students of the KLE College and assisting them to start their working careers.
- Trainers from Deshpande Skilling will utilize the classrooms, computer labs, activity areas and other necessary infrastructure of the KLE College to deliver the SkillPlus skilling program for select students of the KLE College.
- 5. Deshpande Skilling will conduct necessary assessments and selection activities at the KLE College to select the students who need a job, are willing to start working, migrate, and be willing to put in the necessary effort for this. The selection process will be a combination of online assessments, telephonic interviews and face to face interviews. The selection process will be conducted during the 4th semester of the student.
- Students of the KLE colleges selected for the SkillPlus training program will be offered admission to the non-residential program conducted at the college and while the candidate is still pursuing education at the college.
- 7. Deshpande Skilling reserves the right to debar students from the SkillPlus program for lack of seriousness, lack of interest, inappropriate behavior with fellow students or faculty etc. However, the student will be warned and provided an opportunity to correct self before the extreme action of debarment in the best interest of the batch of students.
- 8. Both the parties will work as partners to facilitate selected students of the KLE colleges to develop their employability skills and earn themselves an earning job. However, neither of the parties will charge the other for providing services nor providing the necessary infrastructure.
- 9. DESHPANDE SKILLING will charge a fee of Rs.7000/- from the student. This is only a part of the expenses of conducting the training. Deshpande Skilling collects the fee from the students enrolling for the skilling program to ensure student ownership in the exercise. The balance expenses of the program is funded by CSR funding from corporates and Deshpande Foundation. DESHPANDE SKILLING neither earns profit nor seeks any profit from the activity of skilling.

- 10. The Parties recognize the capabilities and resources that each Party brings and agrees to use their best efforts to bring together those capabilities and resources to collaborate to support skill-based training with DESHPANDE SKILLING. The KLE colleges will support by counselling job-seeking students to take benefit from the skilling program. DESHPANDE SKILLING will support by skilling and placing students of the KLE COLLEGE and enhance its placement record.
- 11. DESHPANDE SKILLING will work with the KLE colleges to build a mindset and discipline among the students of preparing early to earn placement and start a career. Both parties will jointly work to engage the enrolled students through online and offline methods to achieve this.

The Parties are therefore entering into this MOU to record the terms and conditions of this collaboration. **DESHPANDE SKILLING** and **THE KLE Society** have agreed to enter into this MOU to record their present state of agreement in principle in respect of the **SkillPlus College Partnership Program**

NOW IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

This collaboration between DESHPANDE SKILLING and THE KLE Society will be to impart skill training and provide placement assistance to select students of "The KLE COLLEGES" to be able to earn their first employment. The objective of this partnership is to facilitate rural transformation by getting rural youth into productive employment and thereby enhancing the placement record of the partner college.

Roles & Responsibilities of KLE Society and KLE Colleges:

- KLE Society will depute a senior officer with authority and influence at all KLE Colleges to be part of the partnership team.
- The Principal and Staff of the KLE College will align to the spirit of the partnership between Deshpande Skilling and The KLE Society. The Training and Placement Officer of the college will involve actively in the effective conduct of the program.
- KLE College will provide working space within the college for SkillPlus Trainers from Deshpande Skilling who will engage students of the college.
- 4. Deshpande Skilling will be conducting the SkillPlus program after college hours ,holidays and even during college vacation days. The KLE Colleges will facilitate and provide access to classrooms, computer lab rooms, activity rooms, and other college infrastructure to trainers of Deshpande Skilling to conduct the skilling program.



- The KLE Colleges will, if necessary, create additional capacity of computer lab at the college to facilitate smooth conduct of the critical Computer Skill practical classes of the program.
- The KLE COLLEGE will permit and facilitate representatives of DESHPANDE SKILLING to interact with the recommended students and their parents at the college for counselling before admission to the program.
- The KLE Colleges will support the partnership by counselling and encouraging eligible students of the college to enroll for the "SkillPlus" nonresidential skilling program.
- The KLE COLLEGE will recommend students from BA / B.Com/B.Sc. / BBA / BCA / B.Ed. streams or any other streams for which Deshpande Skilling has a working program.
- The KLE COLLEGE will not have an objection to DESHPANDE SKILLING collecting a part of the cost of skilling each enrolled student in the form of fellowship fees from the students.
- 10.KLE Society and the KLE Colleges will allow DESHPANDE SKILLING to list the KLE COLLEGES as its partner on its Web Site and other communication channels.

Roles & Responsibilities of DESHPANDE SKILLING:

- DESHPANDE SKILLING will enter into MOU with the PARTNER COLLEGE and work closely with the college to develop student mindset for "preparing for placement" early and for enhancing placement record of the Partner College by skilling select students at its residential skilling center and provide them placement assistance to earn their job offer.
